#### **RE:** Campus Alberta Quality Council Fourth Annual Report

On behalf of the Campus Alberta Quality Council (CAQC), I have the honour of providing you with the Fourth Annual Report for the period 1 April 2007, through 31 March 2008.

CAQC had an eventful and rewarding year in 2007-08, highlighted by developments that will have a significant impact on the long-term future of post-secondary education in Alberta. It was a very active year as several institutions – university and college level, public and private – brought forward proposals for new degree programs. On the whole, we were impressed both with the quality of the programs proposed to us and with the extent to which collaboration is increasingly becoming a feature of the system in Alberta.

You subsequently approved twenty-four degree programs including a Doctor of Veterinary Medicine proposed by the University of Calgary, and a Doctor of Philosophy in Law proposed by the University of Alberta - the first degree programs of their kind in the Province. As well, you approved first degree programs (other than applied degrees) at Northern Alberta Institute of Technology and Mount Royal College.

In addition to assessing the quality of new program proposals, Council was active in developing and refining its policies and procedures. To that end, Council commissioned an independent review of its activities after three years of operating. The contractor's report, a culmination of feedback from Council members and post-secondary institutions, was considered at the February meeting and an executive summary is available on the CAQC web site. Council is currently developing an action plan to address any issues arising from the review.

The volume of work that the Secretariat and Council have managed has increased greatly. I would like to express gratitude on behalf of Council for the excellent work done by the Secretariat under the leadership of Marilyn Patton. Their hard work, thorough research, sound judgment and commitment to quality have greatly assisted Council, and helped to strengthen Alberta's leadership in educational quality assurance.

It has been a busy, successful year. We look forward to the year ahead, and to new challenges we will surely face, as we work with you to promote high standards for degree programs in Alberta and to implement the changes found in the *Roles and Mandates Policy Framework* and *Bill 7*.

#### **CAQC** Mandate

The Campus Alberta Quality Council is an arms-length quality assurance agency that makes recommendations to the Minister of Advanced Education and Technology on applications from post-secondary institutions seeking to offer new degree programs in Alberta under the terms of the *Post-secondary Learning Act, 2004* and the Approval of Programs of Study Regulation (51/2004).

Other than degrees in divinity, all new degree programs to be offered in Alberta must be approved by the government. Therefore, Council is charged with the quality review of all degree programs proposed by:

- resident public institutions
- resident private institutions, both for-profit and non-profit
- non-resident (out-of-province) public institutions
- non-resident (out-of-province) private institutions, both for-profit and non-profit

## Activities of Council

Council safeguards the public interest in the quality of approved degrees, and also encourages institutions that offer approved degree programs in Alberta to keep improving the management of quality of their degree programs. During the reporting year, Council held four two-day meetings. Council focused on the following areas of activity:

- establishing and refining its procedures and assessment practices
- communicating the role of Council to stakeholders within the province and to relevant national bodies as well as with other provincial quality assurance agencies
- conducting program and comprehensive evaluations
- offering advice on academic standards and quality
- making recommendations to the Minister on applications from post-secondary institutions seeking to offer new degree programs
- responding to the Ministry's Roles and Mandate Framework discussions
- responding to the Board Governance Review Taskforce

Establishing and Refining Procedures and Assessment Standards and Guidelines Council continues to establish assessment materials appropriate to its mandate. During the reporting year, Council developed and adopted the following documents (a short description of these materials is available in Appendix 2):

- Independent academic experts
- Policy on release of information
- Standards on academic staff for baccalaureate programs

As well, Council revised the following documents:

- ► CAQC expectations for design and structure of undergraduate degrees
- Expedited review process description
- Guide for teams conducting program evaluations Graduate programs
- Guide for teams conducting program evaluations Undergraduate programs
- Monitoring of approved degree programs
- Organizational assessment standards General

Three-Year Review

In keeping with its operating principle of commitment to the review of its own activities, Council engaged the services of an independent contractor to determine the effectiveness of CAQC and to establish the level of satisfaction with Council and its Secretariat among CAQC members and post-secondary institutions. The contractor's report was considered at its February meeting and an executive summary is available on CAQC's web site. As noted below, a subcommittee has been tasked with preparing an action plan to address any issues arising from the report.

#### Subcommittees

Council has established one standing committee, and three additional ad-hoc committees to facilitate its work.

Proposal Review Standing
Committee

In keeping with its commitment to being expeditious, Council 's Proposal Review Standing Committee (PRSC), the only standing committee of Council, acts on behalf of the full Council in reviewing requests for expedited reviews and conducting desk reviews of proposals undergoing fully expedited reviews. In addition, the committee has also reviewed substantive changes in approved degree programs and changes to degree or program names. In 2007-2008, the PRSC reviewed eighteen proposals on behalf of Council.

Nomenclature and Degree Programs Subcommittee

During the reporting year, the Nomenclature and Degree Programs Subcommittee held three meetings. The Subcommittee is comprised of Council members and representatives from three stakeholder groups: the Alberta Universities Association (AUA), the Alberta Association of Colleges and Technical Institutes (AACTI), and the Private Accredited Post-secondary Institutions Council (PAPIC). During the reporting year, the Subcommittee finalized the degree requirements for Bachelor of Arts, Bachelor of Science, Bachelor of Education, and Bachelor of Technology degree programs, and continues to work on expectations for Business and Music degree programs, as well as on guidelines for 2+2 and Applied Degree programs. These standards and guidelines are (or will be) included in the document *CAQC's Expectations for Design and Structure of Undergraduate Degrees* which is available on Council's web site.

Three-Year Review Subcommittee

Council struck a Three-Year Review Subcommittee in the previous year to prepare a plan for the review of Council and its work after three years of operating. As noted above, the questionnaires were administered in this reporting year and the independent contractor's report was received in February 2008. This subcommittee is preparing an action plan to address issues arising from the review and will present a draft to Council at its May 2008 meeting. Once the plan has been approved by Council, it will be posted on the CAQC web site.

Working Group on Quality Assurance of Off-campus and International Degree Programs The new Working Group on Quality Assurance of Off-campus and International Degree Programs, comprised of representatives from the Universities of Alberta and Calgary, the Director of International Education Branch of the Ministry, as well as Council Chair and CAQC Secretariat Director, was established to consider principles and guidelines pertaining to off-campus and trans-border degree program delivery.

At its first meeting on 18 March 2008, members adopted the Working Group's Terms of Reference, deliverables, and timelines. Following consultation with stakeholders, it is anticipated that a draft set of principles and a checklist will be presented to Council at its September meeting.

#### Stakeholder Engagement

Opportunities under the *Post-secondary Learning Act* for the establishment of degree programs in Alberta, coupled with a growing demand for degree credentials, have aroused considerable interest across the post-secondary system. Thus, Council works with stakeholders as it develops policies and guidelines to assess and enhance the quality of degree programs. For example, AUA, AACTI, and PAPIC vetted three of the documents before they were adopted by Council during the reporting year: *Policy on Release of Information, Standards on Academic Staff for Baccalaureate Programs*, and *CAQC Expectations for Design and Structure of Undergraduate Degrees*.

As well, the Chair and the Director of the CAQC Secretariat met with institutions and other stakeholders to explain Council's principles and procedures and to seek input on the best ways in which to serve the interests of the post-secondary system and its learners.

In 2007-2008, meetings were held with the Honourable Doug Horner, Minister of Advanced Education and Technology and his Executive Assistant Jason Krips, Deputy Minister Bob Fessenden, and Assistant Deputy Minister Phil Gougeon. Meetings also took place with other officials from the Ministry to:

- ensure that the department's system coordination review and Council's quality assessment mandate are coordinated as much as possible
- ensure that information requirements with respect to program proposals are harmonized
- work together with the International Education Branch with respect to trans-border delivery of degree programs.

As well, the chairs of CAQC and the Alberta Council of Admissions and Transfer (ACAT) met to discuss how the two councils could collaborate to serve Alberta learners. Currently, through its Secretariat, Council is helping ACAT with its project to identify best practices with respect diplomas and certificates.

During the reporting year, Council's Chair and members of the Secretariat met with officials from post-secondary institutions to discuss current Council initiatives and to provide a clearer understanding of degree approval and quality assessment processes. Individual meetings and consultations were held with officials from institutions (resident and non-resident) that are interested in offering new degree programs in Alberta and those currently offering approved degree programs in the Province.

#### National and International Initiatives

To promote the national and international recognition of Alberta degrees in the absence of national accreditation in Canada, it is vital that provincial representatives communicate regularly. The development of connections through the Council of Ministers of Education, Canada (CMEC) and among provincial quality assurance agencies has thus been a priority.

Council's Secretariat has been involved in an important national initiative – the CMEC Quality Assurance Subcommittee, which continues its work under the chairmanship of Marilyn Patton, Director of Council's Secretariat. The Subcommittee's work at the pan-Canadian level will not only improve the understanding of Canadian degrees and how they are assessed, but will also facilitate interprovincial student mobility. In April 2007, CMEC announced that ministers in all provinces and territories had endorsed a *Ministerial Statement on Quality Assurance of Degree Education in Canada*. The statement contains a Canadian Degree Qualifications Framework as well as standards and processes for assessment of new degree programs and new degree providers. **Evaluations and Recommendations** 

The full process of approval for new degree programs being proposed is as follows:

Application to the Minister

System coordination review by the Department

Referral to Council for organizational review (if necessary) and program quality review

▼
Council's recommendation to the Minister

Decision by Minister with respect to approval of the program

For institutions that have experience in offering degree programs at the level of the degree being proposed, a fully expedited review (no organizational evaluation and a desk review by Council's PRSC and Secretariat rather than engaging external evaluators for the program review) or partially expedited review (one not requiring an organizational evaluation) may be possible. Council's criteria for expedited review are published on its web site.

Council is committed to having review processes that are iterative in nature. It works closely with institutions during the review process to foster continuous development and improvement of degree programs.

Applications Referred to Council and Council Recommendations

Of the 24 proposals approved by the Minister during the reporting year, three were approved under different names following Council's recommendation. As well, one major, International Communications, in Mount Royal College's proposed Bachelor of Communication was not recommended to the Minister for approval.

The period of time it took from Council's receipt of an institution's full program proposal to Council's recommendation to the Minister ranged from one to 17 months. For eight percent of the proposals, Council made its recommendations within one month of receiving the full proposal. More than half of the recommendations (58 percent) were made between two and six months of receiving the full proposal. For the remaining proposals, only two took longer than 10 months for Council to make a recommendation. The time it takes for Council to make a recommendation is affected by various factors such as the completeness of the institution's final proposal, whether or not an organizational evaluation is required before the program review, the time it took to recruit external reviewers and establish a site visit date mutually agreeable to all reviewers and the institution, and whether or not the institution was asked to provide further refinements of the proposal.

## Other Activities of Council

#### **Evaluation Teams**

As noted in Council's third operating principle, peer evaluation forms the basis of Council's review of the applicant's ability to implement and sustain degree programs and the quality of the proposed program. Recruitment of appropriate external experts to help with its evaluations is an important activity as the quality of the reviewers affects the quality of the review, which in turn affects the quality of the program under review. Council ensures that the external reviewers' perspective being brought to the evaluation process is a judicious mix of relevant technical expertise and a detached external stakeholder point of view. Depending on the circumstance, Council employs three types of teams of experts in evaluating proposed programs and monitoring approved degree programs:

Organizational evaluation teams assist Council in examining the extent to which the systems and processes of the institution are clearly established to achieve excellence in learning.

*Program evaluation teams* help ensure that degree programs offered by institutions are of an acceptably high quality, and comparable in quality to other degree programs in Alberta and Canada.

Comprehensive evaluation teams help fulfill Council's obligation with respect to periodic evaluations of institutions offering approved degree programs.

All evaluation teams are thoroughly prepared by the Secretariat. Teams have an orientation meeting with the Chair and Secretariat advisor prior to their site visit, and are provided with a comprehensive binder outlining their roles and responsibilities, the assessment standards to be used and detailed information about the proposed program and/or the institution. The Director or Manager of the Secretariat coordinates the review and acts as an advisor to the team during the site visit. Once the review is completed, team members and the institution are asked to provide feedback about their experience and offer suggestions for improving the review process.

Evaluators are typically senior academics and administrators from universities or other institutions offering approved degree programs in Alberta or elsewhere in Canada. In 2007-2008, however, two reviewers were recruited from the United States. Just over half (54%) of reviewers were from outside Alberta during the reporting year. Engaging reviewers from outside Alberta is a deliberate strategy to ensure scrutiny from outside the province for programs, and to expand national and global recognition and reputation of degrees and graduates from Alberta. The final decisions on all matters relating to an evaluation team rest with Council, including the team's membership and its terms of reference.

#### **External Evaluators**

Council relies on the expert opinions of external (peer) evaluators for both phases of its quality review. In 2007-2008, Council recruited 37 reviewers who are widely respected experts in their respective disciplines and who include university professors, Canada Research Chairs, and university administrators. External experts engaged by Council adhere to the Campus Alberta Quality Council Code of Conduct which ensures that they avoid any actual or perceived conflict of interest including that which may impair or impugn the integrity, impartiality or independence of Council.

### Monitoring and Periodic Review

The Approval of Programs of Study Regulation outlines Council's responsibilities with respect to monitoring of approved new degrees. Should it determine that the institution no longer meets the required organizational conditions or that the approved program no longer meets required standards of quality, Council may recommend that approval be discontinued.

Council monitors approved degree programs to ensure that its standards of quality continue to be met. Monitoring may take various forms including annual reporting, periodic reporting, comprehensive evaluations, as well as subsequent evaluations. It may also ask for reporting prior to, or immediately after, implementation of a new program.

Annual Reporting

During 2007-2008, Council advised degree-granting institutions of its new reporting timeline for their annual updates to Council. According to the new requirement, all private degree-granting institutions, as well as Mount Royal College, Grant MacEwan College, and NAIT have to provide Council with their annual updates by 1 November each year to enable Council to review them at its December meeting. This change was made in order to decrease the time lag between the end of the reporting period and the time of Council's feedback to the institutions regarding their approved degree programs.

Comprehensive Evaluation

In addition to annual reporting, Council also conducts periodic review. Normally Council conducts at least one comprehensive evaluation (a combined organizational and program(s) evaluation) of an institution offering approved degree programs in Alberta five years from the time of initial degree granting approval. During the reporting year, a first comprehensive evaluation began with respect to Taylor University College and Seminary and the approved degrees it has been offering since 2001.



#### CAQC's Web Site

To enhance effective communication and dialogue with its stakeholders and members of the public, Council continues to develop its presence on the Internet. The web site (www.caqc.gov.ab.ca) includes information about Council, the application process for new degree proposals, its assessment standards, relevant publications, its recommendations and applications under review, as well as links to relevant legislations and related organizations. Council's web site is kept current to allow stakeholders easy access to Council's documents and activities.

As shown below, activity on the web site was brisk during 2007-2008. The number of visits and the number of unique visitors to the web site increased by more than 40 percent over the previous year.



#### CAQC Secretariat

The CAQC Secretariat assists the Chair and Council in their activities by providing advice on matters of policy and procedure, organizing meetings, helping to set meeting agendas, and preparing publications. It also provides information and advice in response to inquiries from various agencies, current and prospective applicants, and members of the public about matters related to quality assurance of new degree programs. As well, it coordinates all aspects with respect to Council's external evaluation teams and the Secretariat's Director or Manager serves as an advisory member on the teams.

#### **Next Steps**

During the reporting year, Council reviewed the highest number of proposals since its inception, making 2007-2008 one of its busiest years. The number of referrals from the Minister for both Alberta and non-resident institutions is likely to increase in 2008-2009.

In the coming year, Council will continue to strive to improve. It expects to review its operating principles, and will adopt and implement an action plan to address any issues raised during the independent review of its activities. Further, it will continue to gather feedback from reviewers and applicant institutions following each site visit.

Council also expects to review the products of the Working Group on Quality Assurance of Off-campus and International Degree Programs, as well as new degree guidelines developed by the Nomenclature and Degree Subcommittee.

Council will continue working on enhancing the quality of degree programs in Alberta, and on recognition of its assessments, both nationally and internationally. To that end, it will maintain relationships with its provincial and regional counterparts and with pan-Canadian quality assurance initiatives as it expresses its ongoing commitment to post-secondary education in Alberta and to the students who are the beneficiaries of this commitment. It will also work more closely with ACAT in its service to Alberta learners.

## Appendix 1 Campus Alberta Quality Council Key Operating Principles

- 1 The Council **standards** are appropriate to the program level/scope and are comparable to national and international standards. Within this context, Council is open to flexibility and innovation in degree programming.
- 2 The Council respects the foundational role of **academic freedom** in the provision of high quality post-secondary programs.
- **Peer evaluation** is an essential component of the Council's evaluation of post-secondary degree programs.
- 4 Stakeholder participation is an integral part of the degree appraisal process.
- 5 The Council acts to develop and retain autonomy from influences that may undermine or otherwise affect trust in its functions and decisions.
- The Council exhibits **equity** in all aspects of its operation. Equity encompasses the idea that applicants are treated fairly but not necessarily identically.
- 7 The Council exhibits and promotes **openness and transparency** in all its practices and policies. In its commitment to consistency of decision making, the Council aims to develop public trust that all eligible institutions meeting the Council's standards and practices will be able to apply and take part fully in the functioning of the Council under its mandate, administration and processes.
- 8 Processes established by the Council are considered **iterative** in nature. This means that the Council's decisions and judgments have the potential for continuous development and improvement of institutional degree programs.
- 9 Within the context of its iterative processes, the Council acts **expeditiously** and in keeping with principles of natural justice.
- The Council is committed to the **quality assurance review** of its own activities and to the interprovincial sharing of best practices in post-secondary degree program quality assessment. Its processes are dynamic and continuously improving.
- The Council exhibits and promotes **appreciation of institutional diversity** and respect for institutional autonomy and integrity among the institutions proposing degree programs.
- The Council ensures that approved degree programs and Council decisions with respect to them are **monitored** and the extent of monitoring is appropriate to the experience of the institution.
- Members and peer reviewers shall act in accordance with **ethical standards** and abide by Council's code of conduct which includes provisions on conflict of interest.

The guide provides information for external evaluation teams with respect to their role and responsibilities when evaluating proposed programs. The "Framework for Program Evaluation" and "CAQC Code of Conduct" are included. The guide is reviewed and updated as needed.

#### A Guide for Teams Conducting Organizational Evaluations (Resident Alberta Organizations)

The guide provides information for external evaluation teams with respect to their role and responsibilities when conducting organizational evaluations of first-time applicants. The "Framework for Organizational Evaluation and Scorebook" is included. The guide is reviewed and updated as needed.

#### A Guide for Teams Conducting Evaluations of Proposed Graduate Programs

The guide provides information for external evaluation teams with respect to their role and responsibilities when conducting comprehensive evaluations. The "CAQC Code of Conduct" is included. The guide is reviewed and updated as needed.

#### Standards on Academic Staff for Baccalaureate Programs

Council finalized its standards with respect to academic staff teaching in undergraduate programs. The document was approved and adopted by Council at its May 2007 meeting.

#### Hosting a Site Visit

This document offers guidance to institutions to assist them in preparing for a site visit by a Council-appointed external evaluation team.

#### **Independent Academic Experts**

Normally, Council requires institutions to include with the proposal the full report of academic expert(s) engaged by the institution as well as the institution's response. This document provides guidelines to institutions for their selection of independent academic experts.

#### **Institutional Self-Study Guidelines**

This document assists institutions in preparing for a self-study, which is required for Council's organizational and comprehensive evaluations.

#### **Policy on Release of Information**

After an extensive consultation process with various stakeholders, Council published its Policy on Release of Information with respect to its review processes and decisions.

#### Monitoring of Approved Degree Programs

The document outlines different kinds of periodic evaluation undertaken by Council in fulfillment of its monitoring role.
