**RE: Campus Alberta Quality Council Eleventh Annual Report**


On behalf of the Campus Alberta Quality Council (CAQC), we have the pleasure of providing you with our Eleventh Annual Report for the period 1 April 2014 through 31 March 2015. This report highlights some of the main activities in which CAQC has been engaged during a busy and productive year. On Council's recommendation the Minister of Innovation and Advanced Education, approved fourteen degree programs proposed by resident institutions. Nine of these were at the undergraduate level and five were at the graduate level. Each program was thoroughly examined and evaluated using the standards established and published by CAQC.

During the reporting year, Council continued to work closely and proactively with post-secondary institutions on a number of collaborative projects, with the purpose of supporting effective quality assurance at both institutional and system levels. Council, working with the Comprehensive Academic and Research Institutions and the Ministry, co-organized a workshop sharing effective practices in institutional quality assurance as recommended in the final report of the Audit Pilot Task Force last year. The workshop attracted over 70 participants from all sectors of Campus Alberta and the Ministry. The Co-Chairs also met with the Vice-Presidents Academic of the Comprehensive Community Institutions to discuss collaborative delivery of degrees and expectations for scholarly activity for faculty teaching in degree programs. The Monitoring Standing Committee of Council (MSC) continued a collaboration with Mount Royal University, Grant MacEwan University, NAIT and SAIT to develop appropriate expectations and indicators of scholarly activity for faculty staffing their baccalaureate programs. This initiative has resulted in significant changes in institutional approaches to quality assurance indicators. MSC also provided feedback on the results of two institutional cyclical program reviews and provided advice to four institutions regarding their policies and procedures for such program reviews. A meeting is scheduled for MSC and the Vice-Presidents Academic of the Independent Academic Institutions to discuss ways in which Council can provide feedback to this sector on internal quality assurance policies and procedures and expectations for scholarly activity.

Council was pleased to welcome two new members this year and with these additions we continue to better represent the diversity of degree granting sectors. Council also maintained a close relationship with the Ministry through regular meetings with Ministry officials and was pleased to have Ministers attend Council meetings on two occasions.

CAQC is committed to the quality of the degree-level programming offered in Alberta and observes that, in the context of the changes in the post-secondary landscape during the first decade of Council's work, we are confident that institutions within the system share that responsibility appropriately with Council and with the Ministry. We would like to acknowledge the excellent work of Council members and the Director and three other members who comprise the highly skilled and professional Secretariat. We also thank the Ministry for on-going support and confidence in our work.

## CAQC Mandate

The Campus Alberta Quality Council is an arms-length quality assurance agency that makes recommendations to the Minister of Innovation and Advanced Education (IAE) on applications from post-secondary institutions seeking to offer new degree programs in Alberta under the terms of the *Post-secondary Learning Act (PSLA)* and the Programs of Study Regulation (91/2009). CAQC's Mandate and Roles Document outlines the Minister's and Council's responsibilities and accountabilities.

Other than degrees in divinity, all new degree programs to be offered in Alberta (including those proposed by non-resident (out-of-province) institutions) must be approved by the government. Council is charged with the quality review of new degree program proposals referred to it by the Minister. It also monitors degree programs approved on its recommendation to ensure Council's standards of quality continue to be met.

## Activities of Council

Council is committed to ensuring the quality of proposed degrees, and encouraging institutions to continue enhancing the quality of their degree programs. During the reporting year, Council focused on the following activities:

- ▶ conducting program evaluations and making recommendations to the Minister on applications from post-secondary institutions to offer new degree programs
- ▶ monitoring approved degree programs to ensure their compliance with Council's conditions and quality standards
- ▶ refining Council's procedures and assessment practices with respect to program proposals and monitoring activities
- ▶ working with post-secondary institutions to assist them to improve the quality of the new degree programs they propose
- ▶ providing feedback to institutions on the development of their internal quality assurance policies and processes
- ▶ offering advice to institutions on Council's quality standards and review and monitoring processes
- ▶ communicating the role of Council to stakeholders within the province and to other provincial quality assurance agencies and the public
- ▶ proactively scanning for effective quality assurance practices in other jurisdictions.

In 2014/2015, Council held four meetings, and in keeping with its desire to visit institutions, met at Concordia University College of Alberta, the University of Lethbridge, Lethbridge College and Grant MacEwan University. The host institution had an opportunity to present on its current programs, quality assurance processes, success in implementing approved programs, and future plans.

## Action Plan 2014-2017

As required by the *Public Agencies Governance Framework*, all advisory councils accountable to the Minister are expected to have an action plan identifying priorities to be undertaken during a three-year planning cycle in order to fulfill their mandates.

To align its work with this expectation, Council adopted its third Action Plan at the June 2014 meeting. The plan outlined three goals and 14 priority initiatives aligning Council's work with the Ministry's 2014-17 Business Plan. As of 31 March 2015, the implementation status of CAQC's priority initiatives was as follows:

**Goal 1: CAQC will carry out quality reviews that are well-developed, efficient, and evidence-based.**

**Priority initiative**

- ▶ *Support collaboration within Campus Alberta by ensuring that new collaborative delivery of degree arrangements, developed on the basis of the programs approved on Council's recommendation, meet Council's quality standards and conditions.*
- ▶ *Conduct a systematic review of Council's quality assessment processes and guidelines and experience with respect to program proposals from non-resident institutions.*
- ▶ *Explore additional ways to emphasize quality assurance of teaching and learning.*
- ▶ *Examine the use of learning outcomes analysis as a possible future element of assessment processes.*
- ▶ *Work with Ministry officials to implement appropriate responses to the Minister's review of CAQC.*

**Results achieved**

- met with Vice President Academics (VPAs) of Comprehensive Community Institutions involved with collaborative delivery of degrees to discuss Council's scholarly activity expectations
- reviewed documentation and provided feedback on the proposed Mount Royal University – Keyano College collaborative Bachelor of Science (Environmental Science) program
- began reviewing a draft agreement between NAIT and Keyano College to deliver collaboratively NAIT's Bachelor of Business Administration (Management) program at Keyano College
- systematic review not yet scheduled
- discussed the quality assurance of teaching and learning at CAQC's September 2014 retreat, prompted by a background discussion document drafted by a member of Council; members agreed to continue exploring this topic at subsequent meetings
- continued discussions with the VPAs of Baccalaureate and Applied Studies Institutions (BASIs) and Polytechnical Institutions (PIs) on developing reporting indicators to measure quality assurance of teaching and learning
- discussed the evaluation of program learning outcomes at CAQC's September 2014 retreat
- using the recently revised proposal template that makes identification and assessment of program learning outcomes more explicit, continued to assess proposals to determine how well institutions articulate proposed learning outcomes and their assessment
- continued to respond to the 2012 recommendation by updating chair and member competencies and using them in the recruitment process
- broadened the member recruitment process and increased the diversity on Council by adding new members with experience in other sectors
- actively participated in the new initiative to examine the future directions of quality assurance in Campus Alberta and CAQC's role in it (e.g., through participation on the Advisory Committee); this initiative was put on hold by the Ministry in March 2015

**Goal 2: Council will ensure that degree programs approved on recommendation of CAQC continue to meet Council's quality standards and conditions.**

**Priority initiative**

- ▶ Consider the two-year Quality Assurance Audit Pilot Project report with its possible implications for the monitoring of degree granting institutions.<sup>1</sup>
- ▶ Continue to work with institutions to further refine expectations for level of scholarly activity using, as appropriate, adaptations of frameworks such as Boyer's models of scholarship.
- ▶ Assist in the development of quality assurance processes within Campus Alberta, in particular through collaborative interactions with institutions, including co-organizing a provincial workshop to share effective practices in quality assurance.

**Results achieved**

- see below regarding the *Campus Alberta Quality Assurance Workshop: Sharing Effective Practices*
- revised the *CAQC Handbook* to include information about audits
- struck a committee to explore potential extension of the audit process to other degree granting institutions
- held two meetings between the Monitoring Standing Committee (MSC) and the VPAs of the BASIs and PIs to determine the most meaningful way of reporting scholarly activity for both CAQC and the new degree granting institutions
- co-organized (with CARIs and the Ministry) a workshop to share effective practices in quality assurance, which was one of the recommendations in the Audit Pilot Task Force's final report
- reviewed drafts of four institutional policies on cyclical program reviews and provided feedback to institutions
- reviewed the results of two institutional cyclical program review results and provided feedback to institutions

**Goal 3: Council will effectively communicate and collaborate with institutions, government and other stakeholders to maintain quality delivery of degree programs to serve the best interests of learners and contribute to the development of innovation.**

**Priority initiative**

- ▶ Increase Council's proactive interaction and dialogue with stakeholders regarding Council's role and processes.
- ▶ Facilitate collaborative interactions with ACAT around common areas of interest.

**Results achieved**

- communicated regularly with officials from post-secondary institutions to explain Council's principles and procedures and to seek input on the best ways to serve the interests of the post-secondary system and its learners
- continued to work, through the PRSC, with CARIs on modulations of the revised proposal template
- continued to collect and review feedback from reviewers and applicant institutions regarding the efficiency of Council's assessment processes
- made presentations to stakeholders
- updated content on Council's website to enhance Council's communication with its stakeholders and members of the public
- discussed issues of common interest with ACAT (e.g., instructor qualifications, learning outcomes) and explored ways in which the two councils can work together including having CAQC's Co-Chair and the ACAT Chair attend each other's meeting

<sup>1</sup> The Quality Assurance Audit Pilot was a two-year collaborative project of CAQC, Comprehensive Academic and Research Institutions (CARI) and the Ministry. The objective of the project was to ascertain that each of the four CARIs has a quality assurance process for its degree programs that meets the Minister's expectations and that it has applied the process and addressed the review findings with an appropriate response. The project was led by the Task Force consisting of the CAQC and CARI representatives. After the completion of the project the Task Force prepared its final report including five recommendations regarding the future of the audit system in Alberta, all of which were accepted by Council.

- ▶ *Upon appointment of a new CAQC Chair, review and renew the Mandate and Roles document.*
  - ▶ *Through Council's Chair, enhance regular communication with the Minister and senior Ministry officials.*
  - ▶ *Explore ways to provide advice with respect to Ministry initiatives and policies that are relevant to Council's mandate.*
  - ▶ *Through Council's Chair and Secretariat, enhance consultation and share effective practices with post-secondary quality assurance agencies in Canada.*
- updated and renewed Council's Mandate and Roles document
  - discussed Council's role within the larger context of the Ministry's business processes as well as future opportunities for value-added activities
    - Ministers attended two CAQC meetings
    - Regular liaison with senior officials from the Ministry
  - reviewed a draft credentials framework and provided feedback to the Ministry
  - through its Secretariat, continued to participate in networking meetings with quality assurance committees in other jurisdictions
  - began planning a meeting of western provinces' quality assurance agencies in conjunction with a proposed Quality Assurance Workshop; the workshop has been delayed for a year

## Other Activities

### Committees

#### *Proposal Review Standing Committee*

In addition to ad-hoc committees, Council has two standing committees to facilitate its work.

In 2014/2015, PRSC

- reviewed 13 fully expedited review (FER) requests and completed 13 program desk reviews
- completed review of documentation regarding the title change of one degree program
- was considering four FER requests as of 31 March 2015.

PRSC continues to work with CARI representatives on creating modulations of the revised degree program proposal template.

#### *Monitoring Standing Committee*

In 2014/2015, MSC

- assessed and provided feedback on the annual reporting submitted by nine resident and seven non-resident institutions
- provided feedback on draft institutional cyclical review policies submitted by four institutions
- provided feedback on the results of two cyclical program reviews
- met twice with the VPAs of BASIs and PIs to continue discussion on developing new sector-specific indicators for reporting scholarly activity.

### Stakeholder Engagement

As reported under the Action Plan's priority initiatives, CAQC has continued to be actively engaged with institutional and Ministry stakeholders.

### Conferences and Presentations

As it is important that Council's assessments be recognized and understood both within and outside the province, Council's Chair, members, and the Secretariat Director attend meetings and conferences and, in some cases, make presentations relating to Council's work. This year a Co-Chair of the Council made presentations to the Campus Alberta Quality Assurance and CAQC review Advisory Committee, to ACAT members, and to participants at the Campus Alberta Quality Assurance Workshop. In addition, the CAQC Secretariat Director attended the Future of Alberta Digital Learning Forum at Grant MacEwan University.

The process of approval for new degree programs being proposed in Alberta is as follows<sup>2</sup>:



Council's evaluation process is rigorous, depends heavily on impartial external peer review, and takes into consideration the experience of an institution in offering degree programming. When an institution proposes its first degree program, a first degree program at a new level, or other precedent-setting degree, it will normally be subject to a full assessment by Council, including both an organizational and a program review.

For institutions that have experience in offering degree programs at the level of the degree being proposed, a fully expedited review (no organizational evaluation and a desk review by Council's PRSC and Secretariat rather than engaging external evaluators for the program review) or partially expedited review (one not requiring an organizational evaluation) may be possible, according to Council's criteria.

Council is committed to having review processes that are iterative and facilitative in nature, especially in cases when, in Council's opinion, a proposed degree program has potential for development and improvement (CAQC's operating principle 9). Council works closely with institutions during the review process and after a program's approval to foster its continuous development and enhancement. Therefore, it is very gratifying to see (e.g., through annual reporting or through reviewing the results of the institutional cyclical reviews) how these programs are offering quality degree study opportunities for their students.

*Applications Referred  
to Council and Council  
Recommendations*

In 2014/2015, Council made recommendations to the Minister on fifteen programs (ten baccalaureate and five graduate programs) including:

- two programs subject to a partially expedited review (PER) using a CAQC-appointed external evaluation team
- 13 programs subject to a FER by PRSC acting on behalf of Council.


Subsequently, the Minister approved 14 programs and was considering the remaining program as of 31 March 2015. The Minister also approved one undergraduate program previously recommended by Council.

As of the end of the reporting period, Council was reviewing six proposals for graduate and ten proposals for baccalaureate programs. Nine of these proposals are undergoing PERs, and site visits were completed for all but one proposal.

Increasing the efficiency of Council's review processes is a priority. Typically, the review process is shorter for FERs than for PERs. The number of both types of reviews varies annually (e.g., FERs constituted 87% of all reviews in 2014/2015, 47% in 2013/2014, 92% in 2012/2013 and 57% in 2011/2012).

In 2014/2015, the time it took for a Council's review from receipt of an institution's full program proposal to its recommendation to the Minister ranged from 18 to 116 days. This excludes the time during which Council was waiting for additional documentation from institutions.

As the chart above indicates, only three of 15 program reviews (one PER and two FERs) took longer than three months. One of the FER reviews involved review of a revised proposal. All but one of 13 reviews conducted by PRSC involved receiving and processing additional information.

Overall, Council’s review time is affected by factors such as

- the completeness of the institution’s proposal
- whether an organizational evaluation is required before the program review
- the time it takes to recruit external reviewers and establish a site visit date mutually agreeable to all reviewers and the institution (e.g., reviews typically do not occur in the summer)
- whether the institution is asked to provide further refinements of the proposal before a recommendation can be made to the Minister.

The following table outlines the proposals reviewed by Council and/or the degree programs approved by the Minister on recommendation of Council between 1 April 2014 and 31 March 2015.


### Evaluation Teams

Council's fourth operating principle states that peer evaluation forms the basis of Council's assessment of the applicant's ability to implement and sustain the quality of proposed degree programs. Recruitment of appropriate external experts to assist with Council's evaluations is important as the quality of the reviewers affects the quality of the review, which in turn affects the quality of the program under review. Council ensures the external reviewers' perspectives brought to the evaluation process are a judicious mix of relevant disciplinary expertise and an objective external point of view. Council employs three types of expert teams:

- ▶ *Organizational evaluation teams* assist Council in examining the extent to which the systems and processes of the institution establish its capacity to achieve excellence in providing learning credentials at the degree level.
- ▶ *Program evaluation teams* help ensure that degree programs offered by institutions are of an acceptably high quality and comparable in quality to other degree programs in Alberta and Canada.
- ▶ *Comprehensive evaluation teams* help fulfill Council's monitoring role with respect to periodic evaluations of institutions offering approved degree programs.

Once the review is completed, team members and the institution are asked to provide feedback about their experience and offer suggestions for improving the review process. At its September 2014 annual retreat, Council members reviewed all feedback provided and considered consequential refinements to its processes, documents and advice. The feedback indicates a high level of satisfaction with the work of Council and its Secretariat.

Evaluators are typically senior academics and administrators from institutions offering approved degree programs in Alberta or elsewhere in Canada. In 2014/2015, Council's program evaluation and comprehensive evaluation teams included 23 experts (eight from Alberta and fifteen from other provinces).

### **Monitoring and Periodic Review**

Although the quality review of new degree proposals continues to be an important part of Council's work, its monitoring activities are significant as well due to the large number of programs approved on Council's recommendation. The Programs of Study Regulation (91/2009) outlines Council's responsibilities with respect to monitoring of approved degrees.

Monitoring may take various forms including annual reporting, periodic reporting, comprehensive evaluations, audits, as well as review of results of an institution's cyclical program reviews. Council may also ask for reporting prior to or after implementation of a new program.

### *Annual Reporting*

To enable timely feedback regarding approved degree programs, all institutions excepting CARIs, but including non-resident institutions (NRIs), are required to submit their annual reporting by 1 November so the assessments of these reports, prepared by MSC, can be reviewed by Council at its December meeting. For resident institutions not expected to undergo any further comprehensive evaluations by Council, annual reporting for each program approved on Council's recommendation is expected until an institution completes its own cyclical review of that program and Council deems the results submitted to be satisfactory.

### *Comprehensive Evaluation*

In addition to annual reporting, Council normally conducts at least one comprehensive evaluation of a resident institution offering approved degree programs no sooner than in the sixth academic year after the institution begins offering its first degree program. This review typically includes the results of the institution's cyclical reviews of some of its approved degree programs using external evaluators. A subsequent comprehensive evaluation may be conducted.

In 2014/2015, Council conducted its second comprehensive evaluation of Ambrose University and reaffirmed the continuation of approval of the institution's baccalaureate degree programs.

Council has scheduled a first comprehensive evaluation of SAIT in 2016/2017.

## Membership of Council

Council consists of 11 members appointed by the Minister, including a chair and 10 members representing expertise in the post-secondary system (brief biographical information about the members is available in Appendix 1).

## CAQC Secretariat




## A Glance Back

Over the past years, Council has contributed significant value to the post-secondary system in Alberta by ensuring that newly approved degree programs provide quality educational opportunities to learners.

Since its creation in 2004, Council has reviewed and recommended approval of 196 degree programs (137 baccalaureate and 59 graduate). The extent of monitoring of these approved programs varies based on Council's appraisal of the institution's experience and capacity in offering degree programs and its assessment of the rigour and application of the institution's internal review processes.



Of these 196 programs, 64 were proposed by BASIs, six by PI, 83 by CARIs, 26 by Independent Academic Institutions, 14 by NRIs, and one each by a Comprehensive Community Institution, a Specialized Arts and Culture Institution and a private resident institution.<sup>3</sup> The chart below shows the percentage distribution of programs recommended by Council by post-secondary sector (the three institutions with one Council-recommended program each were combined under 'Other' category).




The Minister subsequently approved 188 of these 196 programs, was considering one recommendation as of 31 March 2015 and deferred a decision on the remaining seven.

The map below shows the number of approved programs by institution. Four institutions (University of Alberta, Mount Royal University, Grant MacEwan University and the University of Calgary) account for 64% of all programs approved on Council's recommendation.

(Cumulative as of 31 March 2015)




As the data below indicate, a significant number of enrolments and graduates originate from the programs offered by the relatively new degree granting institutions, Grant MacEwan University and Mount Royal University.

There were also 588 unique learners and 160 graduates in 2014/2015 from NRI programs approved on CAQC recommendation.

Over the past years, CAQC has engaged 215 external reviewers, 44% of whom were from Alberta and 56% from other Canadian jurisdictions, the USA and Australia. The table below shows their geographical distribution. *Note: The 'Other provinces' category includes five reviewers from Quebec, three from New Brunswick and one from Prince Edward Island. The 'Out-of-country' category includes three reviewers from the USA and one from Australia.*



### *Looking Forward*

Council expects the number of new proposals for degree programs will continue to provide a heavy workload. Institutions are reviewing existing degree programs and looking at the potential for new programs that will be attractive to potential students. We also expect that Council will continue to work proactively with institutions from different sectors to support their own internal quality assurance processes. MSC is scheduled to meet early in the next reporting period with institutions from the Independent Academic Institutions and fruitful discussions with the BASI and Polytechnic sectors continue. We have had preliminary discussions with ACAT regarding an initiative on learning outcomes and their assessment and the possibility of a jointly sponsored forum including all of Campus Alberta on this topic is being considered.
